2. The Bidder must have an average annual turnover of not less than Rs.1,00,00,000/- during the last three

financial years (2023-2024, 2022-2023, 2021-2022) and document should be CA certified as per Annexure C.

3. They have satisfactory performance certificate from government/Semi-Govt hospital stating that, they have performed/performing satisfactorily for the past one year. They shall not have labour /staff issues pending with any organizations (as stated above) including ESIC, on the date of submission of bid documents.
